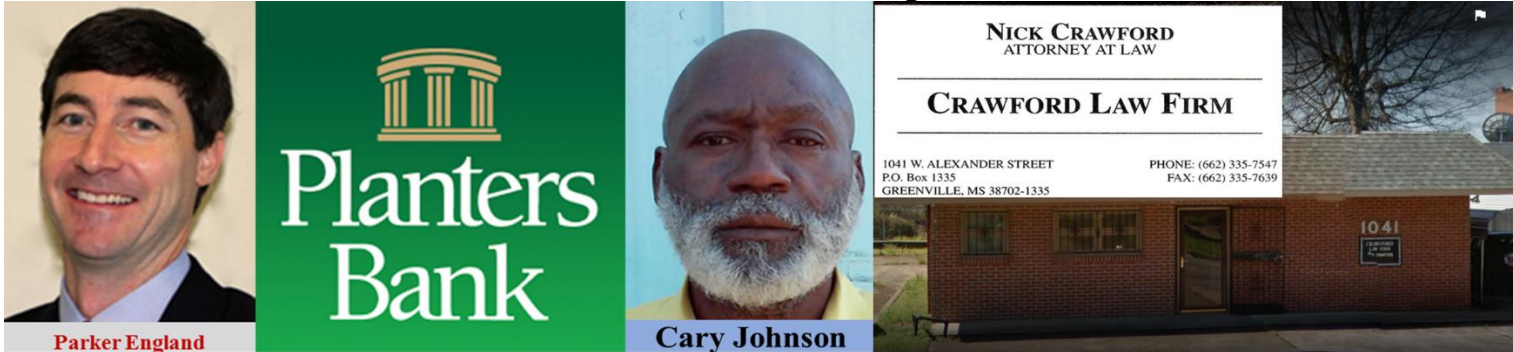

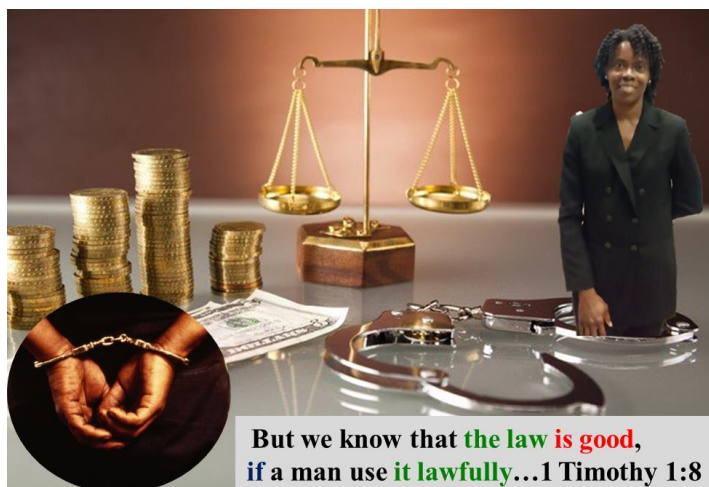

From my understanding, Planters Bank through its Representative (Parker England) and Legal Counsel Nick Crawford of the Crawford Law Firm engaged in CRIMINAL acts in the UNLAWFUL/ILLEGAL seizure of Lands/Territories of Ira Johnson under a STRAWMAN “IRA JOHNSON” through an alleged FORECLOSURE for purposes of MASKING their CRIMINAL and RACIST Attacks! Excerpts of the alleged “DEED OF TRUST” is provided in this correspondence and incorporated by reference as if set forth in full herein:

It appears that that the copy of the “**DEED OF TRUST**” provided Mr. Johnson on 11/29/17, was provided under a FICTIOUS Name “IRA B JOHNSON” and was provided to an Ira B Johnson **with CRIMINAL intent** – FRAUD, DECEPTION, COLLUSION, CONSPIRACY, etc. – without knowledge of Mrs. Johnson that Planters Bank and its Representative(s) were engaging in CRIMINAL Activities for purposes of UNLAWFULLY/ILLEGALLY obtaining possession of her Lands/Properties. I believe each of you will find that although the FRIVOLOUS “DEED OF TRUST” clearly states that it is governed by the “**UNIFORM COMMERCIAL CODE**,” Mrs. Johnson is **NOT** a Business and/or **NEITHER** a Corporation. Mrs. Johnson is a FLESH and BLOOD – Human Being! Therefore, **NOT** subject to the Uniform Commercial Code (“UCC”) and neither can such Terms and/or Conditions under said code apply – See “DEED OF TRUST” at **Page 1**.

THIS DEED OF TRUST is dated April 25, 2014, among IRA B JOHNSON, whose address is 26 J3 (“Grantor”); Planters Bank & Trust Company (referred to below sometimes as “Lender” and sometimes as “Beneficiary”); and Harold H Mitchell Jr (referred to below as “Trustee”).

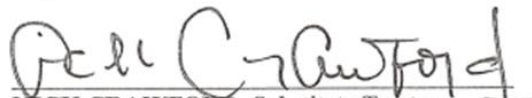

#### Indictment and trial

### **OPERATION GREYLORD**

The first defendant to be found guilty was Harold Conn, Deputy Traffic Court Clerk in the Cook County judicial system. Conn was convicted in March 1984 and was one of the many bagmen in the ring of corruption.<sup>[9]</sup> The last conviction was that of Judge Thomas J. Maloney, who was indicted in 1991 on bribery charges and convicted in April 1993 of fixing three murder cases for more than \$100,000 in bribes.<sup>[10]</sup> Maloney was released from federal prison in 2008, and died the same year.

A total of 93 people were indicted, including 17 judges, 48 lawyers, ten deputy sheriffs, eight policemen, eight court officials, and state legislator James DeLeo.<sup>[2][11]</sup> Of the 17 judges indicted, 15 were convicted.<sup>[7]</sup> One judge, Richard LeFevour, was convicted on 59 counts of mail fraud, racketeering and income-tax violations, and later sentenced to 12 years in prison, as well as being disbarred.<sup>[12]</sup> The stiffest sentence was received by former Circuit Judge Reginald Holzer, who received an 18-year sentence for accepting over \$200,000 in bribes from multiple attorneys.<sup>[13]</sup> Three defendants committed suicide, including former Circuit Judge Allen Rosin.<sup>[14][15]</sup>
